Horizon Europe is the EU's key funding programme for research and innovation with a budget of €95.5 billion.

It tackles climate change, helps to achieve the UN's Sustainable Development Goals and boosts the EU's competitiveness and growth.

The programme facilitates collaboration and strengthens the impact of research and innovation in developing, supporting and implementing EU policies while tackling global challenges. It supports creating and better dispersing of excellent knowledge and technologies.

It creates jobs, fully engages the EU's talent pool, boosts economic growth, promotes industrial competitiveness and optimises investment impact within a strengthened European Research Area.

Legal entities from the EU and associated countries can participate.

4. New elements in Horizon Europe

European Innovation Council: Support for innovations with potential breakthrough and disruptive nature that may be too risky for private investors. This is 70% of the budget earmarked for SMEs.

Missions: Sets of measures to achieve bold, inspirational and measurable goals within a set timeframe. There are 5 main mission areas as part of Horizon Europe.

Open science policy: Mandatory open access to publications and open science principles are applied throughout the programme.

New approach to partnerships: Objective-driven and more ambitious partnerships with industry in support of EU policy objectives.

4. INTELLECTUAL PROPERTY RIGHTS (IPR) —Background and access rights to background

The beneficiaries must give each other, and the other participants access to the background identified as needed for implementing the action, subject to any specific rules in Annex 5. 'Background' means any data, know-how or information — whatever its form or nature (tangible or intangible), including any rights such as intellectual property rights — that is: (a) held by the beneficiaries before they acceded to the Agreement and (b) needed to implement the action or exploit the results. If background is subject to rights of a third party, the beneficiary concerned must ensure that it is able to comply with its obligations under the Agreement.

4. Audits

The granting authority may carry out audits on the proper implementation of the action and compliance with the obligations under the Agreement. Such audits may be started during the implementation of the action and until the time-limit set out in the Data Sheet. They will be formally notified to the beneficiary concerned and will be considered to start on the date of the notification. The granting authority may use its own audit service, delegate audits to a centralized service or use external audit firms. If it uses an external firm, the beneficiary concerned will be informed and have the right to object on grounds of commercial confidentiality or conflict of interest.

4. Audits

The beneficiary concerned must cooperate diligently and provide — within the deadline requested — any information (including complete accounts, individual salary statements or other personal data) to verify compliance with the Agreement. Sensitive information and documents will be treated in accordance with Article 13. For on-the-spot visits, the beneficiary concerned must allow access to sites and premises (including for the external audit firm) and must ensure that information requested is readily available. Information provided must be accurate, precise and complete and in the format requested, including electronic format. On the basis of the audit findings, a draft audit report will be drawn up. The auditors will formally notify the draft audit report to the beneficiary concerned, which has 30 days from receiving notification to make observations (contradictory audit procedure). The final audit report will take into account observations by the beneficiary concerned and will be formally notified to them. Audits (including audit reports) will be in the language of the Agreement.

Who can apply?

Researchers of any nationality with 2-7 years of experience since completion of PhD (Extensions are possible under certain circumstances — see the latest ERC Work Programme), a scientific track record showing great promise and an excellent research proposal.

4. ADVANCED GRANTS

Are you an established, leading principal investigator who wants long-term funding to pursue a ground-breaking, high-risk project? The ERC Advanced Grant could be for you.

Who can apply?

Applicants for the ERC Advanced Grants - called Principal Investigators (PI) - are expected to be active researchers who have a track-record of significant research achievements in the last 10 years.

The Principal Investigators should be exceptional leaders in terms of originality and significance of their research contributions. No specific eligibility criteria with respect to the academic requirements are foreseen.

The goal of MSCA Postdoctoral Fellowships is to enhance the creative and innovative potential of researchers holding a PhD and who wish to acquire new skills through advanced training, international, interdisciplinary and inter-sectoral mobility. MSCA Postdoctoral Fellowships will be open to excellent researchers of any nationality. The scheme also encourages researchers to work on research and innovation projects in the non-academic sector and is open to researchers wishing to reintegrate in Europe, to those who are displaced by conflict, as well as to researchers with high potential who are seeking to restart their careers in research.

4. Horizon Europe Programme Sections

Funding opportunities under Horizon Europe are set out in multiannual Work Programmes, released by the European Commission.

The current main Work Programme is made up of a general introduction, 11 thematic sections included within three priorities complementary and interconnected and a fourth part addressed to strengthen the European Research Area. General Annexes close the Programme, setting out rules which apply across the WPs, such as the standard admissibility conditions and eligibility criteria, selection and award criteria, etc.

4. Horizon Europe Programme Sections

The three priorities are:

- Excellent Science: this priority ensures a strong continuity with Horizon 2020 confirming the support to excellent science of frontier research projects with a bottom-up approach, funding personnel exchanges and fellowships and investing in world-class research infrastructures.
- Global Challenges and European Industrial Competitiveness: it supports top-down collaborative research activities that tackle societal challenges through the identification of six thematic areas of intervention [clusters] and further specific ambitious objectives [missions] involving Member States, stakeholders and citizens.
- Innovative Europe: essentially focus on scaling up breakthrough and market-creating innovation by establishing a European Innovation Council, support the enhancement of European ecosystems of innovation and continued support to the European Institute of Innovation and Technology(EIT). The European Innovation Council will offer a one-stop shop to high-potential innovators. Activities are defined mainly bottom-up.

4. General eligibility conditions for unit costs

In order to be eligible, unit costs or contributions must be: calculated by multiplying the number of actual units used to carry out the work (e.g. number of hours worked on the action, number of tests performed, etc.) or produced by the amount per unit the number of units must be necessary for the action the units must be used or produced during the action duration and the beneficiaries must be able to show the link between the number of units declared and the work on the action. The records and supporting documents must show that the number of units declared was actually used for the action. The actual costs of the work are not relevant.

4. General eligibility conditions for actual costs.

In order to be eligible, actual costs must be: actually incurred by the beneficiary/affiliated entity, i.e.:

- real and not estimated, budgeted or imputed and
- definitively and genuinely borne by the beneficiary/affiliated entity (not by any other entity)
- incurred during the action duration, i.e. the generating event that triggers the costs must take place during the action.

If costs are invoiced or paid later than the end date, they are eligible only if the debt existed already during the action duration (supported by documentary evidence) and the final cost are known at the moment of the final report.

4. EU funding programmes

The EU has several different funding programmes that you may be able to apply for, depending on the nature of your business or project. There are two different types: direct funding and indirect funding.

Direct funding

The allocation of direct funding capital is managed by the European Institutions. There are two types of funding available: grants and contracts. You can apply for grants and contracts managed by the European Commission on the Funding and Tenders portal.

Grants

Grants are given to specific projects that relate to EU policies, usually following a public announcement known as a call for proposals.

Who is eligible?

You may apply for a grant if you run a business or a related organisation (business associations, business support providers, consultants, etc.) that runs projects that further the interests of the EU, or if you contribute to the implementation of an EU programme or policy.

4. Linked third parties (Art. 14 GA)

Linked third parties are not beneficiaries but carry out tasks within the project and declare their own costs (non-profit rule!) in a separate financial statement.

They are subject to the same eligibility rules as the beneficiaries. Linked third parties are eligible if they are named in the Grant Agreement (GA) together with their tasks. Linked third parties may only be parent/subsidiary/associated companies of a beneficiary ("affiliates") as well as organisations with a legal link to a beneficiary.

Third parties providing in-kind contributions (Arts. 11 and 12 GA)

So-called "third parties providing in-kind contributions" provide in-kind contributions to a beneficiary.

Such in-kind contributions may consist of e.g. equipment or research infrastructure, or personnel employed by the third party and working for the beneficiary ("seconded personnel", reported under "personnel costs"). Please note: Not to be confused with staff provided by a temporary work agency (= reported under "contracts"/"other direct costs").
